6. Description of the contract

Supply of equipment (Gas Chromatograph - mass spectrometer with auto sampler pc 1 and Gas Chromatograph head-space with flame ionization detector with auto sampler pc 1 for Toxicology laboratory of National Criminalistic – Technical Centre of Scientific Police of Serbia

TERMS OF PARTICIPATION

8. Eligibility and rules of origin

Participation is open to all companies from Serbia and Spain registered for business which represents the subject of this tender.

9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.2 of International Management Group Procurement Procedures.

10. Number of tenders

Tenderers may submit only one tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot. Tenderers < may/may not > submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

11. Tender guarantee

12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee of 5% of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.]

14. Tender validity

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders.



15. Period of implementation of tasks

100 days from contract signature.

SELECTION AND AWARD CRITERIA

16. Selection criteria

The selection criteria should be clear and non-discriminatory and may not go beyond the scope of the contract. The reference period may not go beyond the past 3 years. Consideration has to be made regarding which proof documents should be requested for the relevant selection criteria. If appropriate for the project and subject to the principle of equal treatment separate criteria for natural persons may be published and applied. If **not** used the reference to legal and natural persons shall be deleted.

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

- 1) Economic and financial capacity of tenderer (based on i.a. item 3 of the Tender Form for a Supply Contract). In case of tenderer being a public body, equivalent information should be provided.
